

2026 BINNACLE BOSS COMPETITION

Terms and Conditions

1. STANDARD TERMS

1.1. Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER

2.1. Entry is open to all students currently undertaking any of Binnacle Training's Certificate programs.

3. HOW TO ENTER

3.1. The competition commences on **Tuesday, 14th of July 2026 (Term 3, Week 1)** at 9:00 AM (AEST) and concludes on **Tuesday 6th of October 2026 (Term 4, Week 1)** at 3:00 PM (AEST) ("the Competition Period").

3.2. Eligibility:

3.2.1. In order to enter, the entrant must be currently enrolled in any course offered by Binnacle Training.

3.2.2. The entrant may apply as an individual or as a team (max 4 students), with all entrants following condition 3.2.1.

3.2.3. For the entry to be eligible in the **Binnacle Boss Competition**, the entrant must create a 3-5 minute video pitch outlining their unique business concept. Video content after the first 5 minutes will not be considered for judging purposes. Entries received after 3:00 pm on Tuesday 6th of October 2026 will not be accepted.

3.2.4. The entrant must complete the online form, including uploading of their video submission, available at binnacletesting.com.au/binnacle-boss.

3.2.5. Video file types accepted are MPEG, MP4 and MOV files only.

3.2.6. For the entry to be eligible, the business idea should not yet have generated revenue of more than \$5,000 p.a.

3.2.7. All entries must include a completed parental consent form for each individual in the team. These must be submitted (along with your video pitch) by way of the online form at binnacletesting.com.au/binnacle-boss.

3.3. Entrants may enter as many times as they like, following condition 3.2.2 and 3.2.3. Subsequent entries must include a different business idea.

4. PRIZES

4.1. There will be three prize winners. The prize winners will be adjudicated by a panel of judges (see condition 5.2). The class teacher of the winning first place entry will also receive a 'Teacher Incentive' (see condition 4.5).

4.2. The first place winner (if an individual) will receive one prize package as set out below:

- The 'Competition' winner will be announced on **Tuesday, 13th of October 2026 (Term 4, Week 2)** between 12:00 - 3:00 PM (AEST).
- The winner will be notified using the contact details provided by the entrant. The winner may also be announced on Binnacle Training's social media platforms (Facebook and Instagram).
- The prize winner agrees for the use of their name and school for publicity and competition purposes, without compensation.
- The Promoter's decision is final and the Promoter will not enter into correspondence regarding the result.
